The National Mining Hall of Fame and Museum in Leadville will hold its Silver Anniversary 25th Annual National Mining Hall of Fame Induction Banquet on Saturday evening, September 22, 2012 at the Las Vegas Hotel & Casino in Las Vegas, Nevada – ahead the opening of the MINExpo 2012 mining equipment exhibition, which opens in Las Vegas on September 24.

This year's National Mining Hall of Fame inductees will be Glen A. Barton, who retired as Chairman and CEO of Caterpillar in 2004; J. David Lowell, a prominent minerals explorationist who discovered or contributed to the discovery of a number of major producing mines; Samuel Newhouse, who developed the first profitable underground mine at Bingham Canyon, Utah; and John Cleveland Osgood, a founder of Colorado Fuel & Iron Company and a coal baron whose influence extended throughout the Rocky Mountain West.



## Opportunity to Cultivate Future Industry Employees

The Minerals Education Coalition (formerly GEM) Subsection invites your company to participate in the Adams County Education Consortium's (ACEC) Experience 9 to 5®. This program was created in 2008 to help students "experience" what it is like to do different careers so they get a better idea of whether it is a fit for them or if they possess the proper skills to be successful.

ACEC Experience 9 to 5® facilitates experiences for high school students to explore careers, polish their professionalism and, overall, to prepare for the world of post-secondary life. Whether they enter the workforce or pursue higher education, the aim is to lessen the gap of employment opportunities against an unskilled workforce.

The program runs on Monday's in October through mid-November from either 4 p.m. – 6 p.m. or 6 p.m. – 8 p.m. It encompasses options from all sectors and runs anywhere from 2 to 12 hours depending on the employer/organization host. During the evening, we ask our hosts to provide an overview of what it is like to be in the business, how you get to be successful, and what gets in the way. We then hope the students are asked to perform a task or exercise that simulates the job so they know better what it takes to do the work.

The program is looking for host organizations to provide an professional work environment where students can experience the types of tasks that are available within your organization, perhaps a lab setting (crushing rock, float tests), use of computer software, simple field work taking soil or surveying, or creating graphical or technical manuals.

ACEC allows you to determine what size group you are willing to host. It is first-come-first-serve. We cover the insurance for the students while they are at your facility. If you prefer to have your people come out to a location in Adams County, we can find you one.

Students start to register for the program in July 2013 so you have time to plan your event. In September, ACEC holds an orientation for all registered students to help them understand the personal commitment of arriving on time and how to get the most out of the experience. From there, students get to the program(s) they registered to attend either through rides with their parents, driving themselves or carpools.
